It's hard to believe it's been over a year since Common App launched its Next Chapter. We're recommitting to our mission to increase access for all students who want to pursue their postsecondary dreams. We've spent the past year working with members, counselors, and other key partners to start our trek to the moon and close our equity gap in students pursuing postsecondary opportunities.

We've learned so much over the past year. We've launched new initiatives centered around helping students afford college, expanded the number of opportunities available to students through our direct admissions offerings and community colleges, and used our unique data to provide insight into application trends across the applicant lifecycle, while identifying potential barriers and opportunities to improve college access. **All of this work yielded an increase of low- and middle-income students using the Common App, a positive sign that we're making progress toward our moonshot goal.** 

This annual report provides a deeper look at our applicant pool and tracks our yearly progress. We'll continue to use this report to understand how much progress we're making together toward closing our equity gap by 2030.

## THE CHALLENGE

We set our baseline for our moonshot goal during the 2022–2023 academic year. At the time:

**30%** of Common App applicants lived in ZIP codes below the national median household income.

70% lived in communities above it.

**To close our equity gap,** we're striving to have both percentages of applicants living in ZIP codes above and below the median income to be **equal**.



#### THE OPPORTUNITY

According to our data, there is a mountain of opportunity focusing on students from low- and middleincome communities who are not currently using the Common App. This strategy will help us close equity gaps, meet enrollment goals, and improve lives.

## TRACKING OUR PROGRESS

Since the 2021–2022 application season, numbers show that the equity gap has been steadily closing.

In the 2023–2024 application season, we reached **422,893 low- and middle-income students.**
